- a. best management practices
- b. reforestation and afforestation
- c. visual quality management
- d. conservation objectives, such as critical wildlife habitat elements, biodiversity, threatened and endangered species, and Forests with Exceptional Conservation Value
- e. management of harvest residue (e.g. slash, limbs, tops) which considers economic, social, environmental factors (e.g. organic and nutrient value to future forests) and other utilization needs
- f. control of invasive species
- g. characteristics of special sites
- h. reduction of wildfire risk and
- i. the use of qualified logging professionals, qualified resource professionals, and/or certified logging companies
- j. Awareness of SFI
- k. Reporting of inconsistent practices
